

Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

Open to Internet users who currently have Internet access and log on to the BuzzBack site (<http://www.buzzback.com>). The Sweepstakes (the "Promotion") begins at 12:00:00 PM (Noon) Eastern Time ("ET") on May 20, 2006 and ends at 11:59:59 AM ET on June 1, 2006. The Promotion is open only to legal residents of the United States who are 13 years of age or older. Employees, officers and directors of BuzzBack ("Sponsor"), its respective parents, affiliates, subsidiaries, advertising, promotional, fulfillment and marketing agencies, their immediate families (parent, child, sibling and spouse) and persons living in the same households as such individuals (whether related or not) are not eligible to participate in the Promotion.

HOW TO ENTER.
